Division of roles and remits of Local Authorities with regard to land use and agriculture

Response to a written request to Hampshire County Council, for information on the roles of different local authorities with regard to specific aspects of land use and agriculture

6 July 2021

In East Hampshire, there is no simple answer to the above question, as the existing framework is a mosaic of responsibilities.

Planning is the major determinant of change of land use, with the power for planning resting on the relevant planning authority – either the South Downs National Park Authority or East Hampshire District Council. Hampshire County Council holds no real power in relation to planning decisions.

Hampshire County Council does hold statutory responsibilities for trading standards, including animal welfare, as well as responsibilities for highways as the local highway authority. Hampshire County Council can theoretically change the designation of a highway from one use to another (e.g. from footpath to bridleway) but has never exercised this power.

Natural England has statutory responsibility for designations of certain types of protected landscapes, such as Sites of Special Scientific Interest (SSSIs) and Sites of Importance for Nature Conservation (SINCs). The Department for Environment, Food and Rural Affairs (DEFRA) manages the various agricultural management schemes, such as the Basic Payment Scheme (BPS) and Higher Level Stewardship (HLS). The Environment Agency has statutory responsibility for water catchment management, which inevitably impacts land use.

There is no one body with statutory responsibility for agriculture or land use, and many of the schemes are voluntary. This can mean that there are limited powers available to any local authority to compel a landowner to behave in a certain way.
